1. This release and waiver covers any and all risks of death, serious injury and property loss whether arising from (i) negligence or carelessness on the part of the persons or entities being released and other participants, and/or (ii) dangerous or defective equipment.

The undersigned certifies that he or she has read this agreement, understands it and signs it voluntarily as his/her own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made.
